

**ANNUAL SCHEDULE OF MEETINGS OF THE
PLAINFIELD MUNICIPAL COUNCIL
JANUARY 1, 2009**

WHEREAS, Public Law 1975, Chapter 231, Section 13, requires a public body to post and maintain posted and to distribute to designated newspapers and to further file with the Municipal Clerk for the purpose of public inspections, a schedule of the regular monthly meeting of such public body to be held during the calendar year; and

WHEREAS, Pursuant to Section 2:2-9(a) as amended of the Municipal Code the Council shall convene in regular meetings on the first Monday of every month, and also on the third Monday of every month at 8:00 P.M. in the Council chambers-Municipal Court, except that when a regular meeting day falls on a legal holiday the meeting shall be held the same hour and place on the next day which is not a legal holiday, unless the Council shall otherwise provide by resolution.

WHEREAS, such schedule of regular meetings is required to contain the location of each meeting, to the extent that it is known, and the time and date of each meeting; and

WHEREAS, Public Law 1975, Chapter 231, Section 3-D, provides that where the annual notice of revisions thereof, in compliance with sections of the subject act, set forth the location, time and date of any meeting, no further action shall be required for such meeting, now, therefore, be it
