

WHEREAS, The Plainfield City Council of the County of Union desires to comply with the letter and spirit of Chapter 231, Public Laws of 1975, otherwise designated as "The Open Public Meetings Act", and cited as N.J.S.A. 10:4-6 et seq.; and

WHEREAS, "The Open Public Meetings Act", and more particularly N.J.S.A. 10:4-18 requires that, at least once a year within seven (7) days following the annual organization or reorganization meeting of this Council, a schedule of the regular meetings of this Council must be posted in at least one public place reserved for such or similar announcements, delivered by mail to the newspapers designated by this Governing Body to be most likely to reach residents of this City, and filed with the Office of the City Clerk, said notice of meetings to also designate the place and time of such meetings; and

Pursuant to Section 2:2-9(a) of the Municipal Code the Council shall convene in regular meetings on Wednesdays following the first and third Mondays of every month other than August and November at 8:00 p.m. in the Council Chambers-Municipal Court, except that when a regular meeting day falls on a legal holiday the meeting shall be held the same hour and place on the next day which is not a legal holiday, unless the Council shall otherwise provide by resolution; and

In preparation for the Regular Council Meetings herein described, the Council shall convene in agenda/work meetings on the preceding Monday of each regular meeting which agenda/work meeting shall be convened at the City Hall Library or such other place as may be established by resolution and public notice.

NOW THEREFORE, BE IT RESOLVED, by the Municipal Council of the City of Plainfield, New Jersey that the schedule of Annual Meetings as amended be further amended in its entirety to read as follows:
