

RESOLUTION AUTHORIZING THE AWARD OF A CONTRACT TO ARNOLDS ROADS, INC. 8 DANTE ROAD, MONROE TOWNSHIP, NJ 08831 FOR THE SOUTH SECOND STREET RESURFACING PROJECT PHASE IV (FROM GRANT AVE TO PLAINFIELD AVE) FOR AN AMOUNT NOT TO EXCEED \$264,925.00

WHEREAS, bids were solicited and duly advertised by the City of Plainfield on June 9, 2009 for the resurfacing of South Second Street Phase IV (from Grant Ave to Plainfield Ave); and

WHEREAS, bids were received on June 23, 2009, at 11:00 a.m. and reviewed by the bid committee consisting of Randolph Laks, of Remington & Vernick Engineers, and David Spaulding, Purchasing Agent for the City of Plainfield; and

WHEREAS, the results from the Bid Opening were as follows:

WHEREAS, after careful review and analysis, the Bid Committee recommends that a contract be awarded to Arnolds Roads, Inc., 8 Dante Road, Monroe Township, NJ 08831, as the lowest responsible bidder; and

WHEREAS, sufficient funds are available in the amount of \$189,741.00 from FY 2009 NJDOT Municipal Aid Fund and in the amount of \$75,184.00 from the CDBG Year 34 account # U-05-41-152-209-475 as evidenced by the Certificate of the City's Chief Financial Officer attached hereto; and

WHEREAS, the South Second Street Resurfacing Project Phase IV is approved from Grant Ave to Plainfield Ave; and now, therefore be it

RESOLVED, by the City Council of the City of Plainfield that a contract for the Resurfacing of South Second Street Roadway Phase IV in the amount of Two Hundred Sixty Four Thousand, Nine Hundred and Twenty Five Dollars (\$264,925.00) be awarded to Arnold Roads, Inc. with a principal place of business at 8 Dante Road, Monroe Township, New Jersey 08831; and

BE IT FURTHER RESOLVED, that said Bidder be required to execute and deliver the contract bond and other documents as set forth in the specifications under which the bid was made within the time period therein specified, and thereupon the Mayor and City Clerk are hereby authorized to execute such a contract;

BE IT FURTHER RESOLVED, that a duly executed copy of this Resolution, and a duly executed copy of the contract be filed in the Office of the City Clerk.
