

**RESOLUTION AUTHORIZING THE AWARD OF A CONTRACT TO DEFINO CONTRACTORS, 28 INDUSTRIAL DRIVE, CLIFFWOOD BEACH, NJ FOR THE SOUTH SECOND STREET RESURFACING PROJECT PHASE III (FROM MORRIS STREET TO GRANT AVE) FOR AN AMOUNT NOT TO EXCEED \$381,074.07**

**WHEREAS**, bids were solicited and duly advertised by the City of Plainfield on April 16, 2008 for the resurfacing of South Second Street – Phase III; and

**WHEREAS**, bids were received on May 15, 2008, at 11:00 a.m. and reviewed by the bid committee consisting of Randolph Laks (Remington & Vernick Engineers), Donovan Hunte, Purchasing Division and David Spaulding, Acting Purchasing Agent for the City of Plainfield; and

**WHEREAS**, the results from the Bid Opening were as follows:

**WHEREAS**, after careful review and analysis, Bid Committee recommends that a contract be awarded to Defino Contractors, 28 Industrial Drive, Cliffwood Beach, NJ, as the lowest responsible bidder; and

**WHEREAS**, sufficient funds are available in the amount of \$265,000.00 from CDBG Year 33 account number U-05-41-152-208-400 and in the amount of \$116,074.07 from Bond Ordinance #1241 account # C-04-55-831-001-901 as evidenced by the Certificate of the City's Chief Financial Officer attached hereto; and

**WHEREAS**, the South Second Street Resurfacing Project Phase III is approved from Morris Street to Grant Ave, with alternates the project could extend to Spooner Ave; and

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Plainfield that a contract for the Resurfacing of South Second Street Roadway – Phase III in the amount of Three Hundred Eighty One Thousand Seventy Four Dollars and seven cents (\$381,074.07) be

awarded to Defino Contracting Co. with a principal place of business at 28 Industrial Drive, Cliffwood Beach, New Jersey 07735;

**BE IT FURTHER RESOLVED**, that said Bidder be required to execute and deliver the contract bond and other documents as set forth in the specifications under which the bid was made within the time period therein specified, and thereupon the Mayor and City Clerk are hereby authorized to execute such a contract;


**BE IT FURTHER RESOLVED**, that a duly executed copy of this Resolution, and a duly executed copy of the contract be filed in the Office of the City Clerk.
