



RESOLUTION AUTHORIZING THE AWARD OF A BID CONTRACT TO SCC CONTRACTORS, 57 MAPLE AVENUE, W. PATERSON, NEW JERSEY FOR DEMOLITION OF FIVE (5) RESIDENTIAL STRUCTURES IN THE CITY OF PLAINFIELD IN THE AMOUNT OF \$120,400.00.

WHEREAS, a bids were solicited and duly advertised by the City of Plainfield, on November 17, 2007, for the demolition of five (5) residential structures in the City of Plainfield; and

WHEREAS, bids were received on December 5, 2007, at 11:00 a.m. and reviewed by the bid committee consisting of Wendell Bibbs (Remington and Vernick Engineers), Donovan Hunte, Purchasing Division and David Spaulding, Acting Purchasing Agent, for the City of Plainfield; and

WHEREAS, the results from the Bid Opening were as follows:

WHEREAS, after careful review and analysis, the Bid Committee recommends that a contract be awarded to SCC Contractors, 57 Maple Avenue, West Paterson, New Jersey, as the lowest responsible bidder; and

WHEREAS, sufficient funds are available from New Jersey Demolition Bond Loan Program from account number P-06-41-732-207-475 as evidenced by the Certificate of the City's Chief Financial Officer attached hereto, Now, therefore, be it,

RESOLVED, by the City Council of the City of Plainfield, New Jersey that a contract is hereby awarded to SCC Contractors, 57 Maple Avenue, West Paterson, New Jersey in the amount of One Hundred Twenty Thousand Four Hundred Dollars (\$120,400.00) for demolition of five (5) residential structures in the City of Plainfield; be it,

FURTHER RESOLVED, that said Bidder be required to execute and deliver the contract bond and other documents as set forth in the specifications under which the bid was made within the time period therein specified, and thereupon the Mayor and City Clerk are hereby authorized to execute such a contract; be it,

FURTHER RESOLVED, that a copy of this resolution and a duly executed copy of the contract be filed in the Office of the City Clerk.


