SUBJECT: Item for City Council Agenda Fixing Session Scheduled for Monday, November 19, 2007, - An Ordinance to Amend and Supplement Chapter 16. Vehicles and Traffic. Article 10. Bus Stops. Schedule XII. - Reeve Terrace

The Director's office of the Department of Public Works and Urban Development is requesting that subject item be placed on Council's subject date agenda and first reading on Wednesday, November 21, 2007.

As per the attached letter dated October 11, 2007 to Detective Kevin Egbert, Traffic Section Plainfield Police Department from Donald Pigford Jr., Senior Field Representative Bus Stop Sign and Shelter Programs, NJ Transit, a City of Plainfield resident residing on Reeve Terrace has requested that a bus stop located on East Second Street at Reeve Terrace (near side) be relocated to the far side of Reeve Terrace to stop commuters from gathering in front of the residence. This was requested at a City Council meeting by the owner of the residence.


The proposes to delete this bus stop.

AN ORDINANCE AMENDING CHAPTER 16, VEHICLES AND TRAFFIC, ARTICLE 10, BUS STOPS, SCHEDULE XII, BY ELIMINATING A CERTAIN BUS STOP AT REEVE TERRACE, OF THE MUNICIPAL CODE OF PLAINFIELD, 1971

BE IT ENACTED, by the City Council of City of Plainfield, County of Union, New Jersey, that Chapter 16, Vehicles and Traffic, Article 10, Bus Stops, Schedule XII, of the Municipal Code of the City of Plainfield, 1971, is hereby amended as follows:

Section 1.

Schedule XII Bus Stops, Part I. Municipal Roads.

19. Along EAST SECOND STREET, Westbound, on the northerly side at:

[c. Reeve Terrace -- (near side)

Beginning at the easterly curbline of Pineview Terrace and extending 105 feet easterly therefrom.]

Section 2. Except as amended herein, the remaining provisions of Schedule XII shall remain in full force and effect.

Section 3. This Ordinance shall take effect twenty (20) days after final passage and approval as provided by law. This Ordinance shall be published in the official newspaper of the City of Plainfield as required by law.
