

TO FINANCE UEZ PROJECT #08-27ADM TITLED PLAINFIELD UEZ  
ADMINISTRATIVE FY08 BUDGET

WHEREAS, the City Council of the City of Plainfield on April 4<sup>th</sup>, 2007 approved Resolution R 149-07 requesting \$129,252 from the Urban Enterprise Zone to finance the Plainfield UEZ Administrative FY 08 Budget Project; and

WHEREAS, there is sufficient funding, as evidenced in the Urban Enterprise Zone Projects Status report dated April 30, 2007;

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Plainfield that the prior acceptance by the City Administrator is hereby ratified and the Mayor and the City Clerk are hereby authorized to execute such additional documents necessary to accept the award in the amount of \$129,252 from the UEZA to finance the city's Urban Enterprise Zone Project titled Plainfield UEZ Administrative FY08 Budget;

**RESOLUTION FOR AUTHORIZATION TO SUBMIT AN  
APPLICATION TO THE NEW JERSEY URBAN ENTERPRISE ZONE  
PROGRAM, ZONE ASSISTANCE FUND FOR A  
FISCAL YEAR 2008 ADMINISTRATIVE BUDGET IN THE AMOUNT OF  
\$129,252**

WHEREAS, the City of Plainfield is a designated New Jersey Enterprise Zone community, providing incentives for businesses to locate into our municipality and improve their competitive edge by reducing their operating cost and qualifying eligible businesses operating in the Urban Enterprise Zone to collect 3.5 % sales tax, rather than the full 7%: and

WHEREAS, the reduced sales tax revenue collected is deposited in the Enterprise Zone Assistance Fund by the New Jersey Division of Taxation and are made available to the City of Plainfield for programs, projects and their administration to promote economic development; and

WHEREAS, the City of Plainfield Office of Economic Development is requesting funding in the amount of \$129,252, for the fiscal year 2008 local administration of the Urban Enterprise Zone from the New Jersey Urban Enterprise Zone Authority; and

WHEREAS, this is an eligible use of Enterprise Zone Assistance Fund revenues and there is sufficient deposits in the Plainfield Enterprise Zone Account Status as evidenced by the UEZ Account Status Zone Administration Report, dated February 28, 2007, attached hereto;

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Plainfield that the Mayor and the City Clerk are hereby authorized to submit an application to the Urban Enterprise Zone Authority in the amount of \$129,252 for the City of Plainfield Fiscal Year 2008 Urban Enterprise Zone Administrative Budget, as presented in the attached application; and

BE IT FURTHER RESOLVED, that the Mayor and the City Clerk are authorized to execute such contract documents as may be required subject to the review and approval of the Corporation Counsel; and

BE IT FURTHER RESOLVED, that a duly executed copy of this resolution and Administrative Budget for Fiscal Year 2008 be filed in the Office of the City Clerk.
